The Tests of Causation

Standard Test: "But for"

- (1) Cause in fact established where **"but for" the negligent acts of D, P would not have suffered an injury;**
- (2) Cause in fact **not** established if **P would have suffered the same harm had D not acted negligently.**

Tests of Causation

Alternative Test: “Substantial Factor”



Scientific Evidence



- * Admissibility of Expert Testimony
- * Factors Considered by Court
 - (1) whether testimony reflects “scientific knowledge”;
 - (2) whether testimony is relevant
